Call to Order

The meeting was called to order at 9:10 a.m.

Introductions and Quorum Determination

A quorum was confirmed

• Review and approval of the March 7th meeting minutes

Minutes approved by Randal Johnson and seconded by Dana Antoon

Magellan Single PBM

- Randal Johnson: Did Magellan finish the reprocessing? Two pharmacies experienced payment delays from Magellan. One was Marty McCay at Pearson Drugs and Rebecca Reed's Pharmacy. I think the department has a big announcement they made last week.
- LDH: During the P&T Committee Meeting, Undersecretary Michael Harrington announced, the brand vs generic will be discontinued 6/30/24. Generic Revatio suspension will be preferred. Brand Revatio suspension will be nonpreferred.
- Dr. Wanda Thomas: How will providers receive the list?
- LDH: Providers will receive the list. We emailed a list. Please pull the list up.
- LDH: Supplemental rebate goes away now for these drugs.
- M.J. Terrebonne: I think the communication needs to go out in the early part of June.
- LDH: We cannot move generics to preferred status until July 1.
- Randal Johnson: Does this cause a problem with the rebate agreement?
- LDH: Yes
- M.J Terrebonne.: Do we have a timeline?
- LDH: We will let you know about the timeline.
- LDH: There is an independent pharmacy charging a stocking fee to Medicaid recipients. LDH Legal will send letter to have pharmacy reimburse the recipients.

MAC Pricing update

 M.J. Terrebonne: Kim reported an independent consultant reviewed the report and upper management has not made any decisions. On the iPad is a

- copy of the 3 Axis report. In their findings, they found the generic cost increased early on but since moderated.
- LDH: Local pharmacy reimbursement is based on the Pharmacy FFS rate, non-local rate is based on contract. There is an issue with encounters resubmission.
- Randal Johnson: How far back do encounters go?
- LDH: The last financials were on 12/31/23. Milliman does not have encounter dates but they have a way of getting information.
- M.J. Terrebonne: No one entity has a complete set of everything. There is a delay with receiving encounters.
- Randal Johnson: Why is Magellan having problem submitting encounters?
- LDH: If the file is not setup correctly on Magellan side, Gainwell will not be able to receive the file.

Milliman Report Mid-Year PMPM rate adjustment

- M.J. Terrebonne: At the last meeting, Kim provided an update. Regarding pharmacy, the rates increased to seven percent. Last we knew this was going to CMS for approval.
- LDH: We do know Milliman was told about brand over generic.
- o M.J. Terrebonne: We will be looking at the rate again.
- LDH: We are working on the rates for July.
- LDH: The report will be in draft rates not final. Milliman already set the rate for 7/1.

Pharmacy Budget Update

o LDH: no issues. The PMPM is the budget for MCOs. The pharmacy budget is fee-for-service. There is not a pharmacy budget other than fee-for-service.

• Reports MCO Templates

- M.J. Terrebonne: Sue emailed the report templates. On the MCO report, how do you obtain a copy?
- Randal Johnson: If we requested the number of Medicaid scripts filled by a particular NPI, how would we request that information from the department?
- LDH: A public records request will need to be submitted. Staff receives the request and provides the information.
- M.J. Terrebonne: Myers & Stauffer could pull the report. Does any report have a 12-month period? Who maintains the reports?
- LDH: We review a rolling 12 months of data. Some of the information rolls into the transparency report.
- LDH: We will send it to the program staff. As long as it's clear.
- Randal: From the reports in the file, can you tell us which one?
- M.J. Terrebonne: The last transparency report is 2021. The pharmacy information is located on page 43 and number of claims PA on page 44.
- LDH: Magellan removing Auto PA process by tiers.

 LDH Legal continues to remind the MCOs they are well within their rig hts to hold Magellan on compliance issues.

Provider Fee Update

- M.J Terrebonne: I thought you were working with Myers and Stauffer
- LDH: M&S issued a report that you have seen. Kim said to wait until a fter session to do anything else.

• Thirty-Day Supply Policy

- M.J. Terrebonne: I know this is coming up. I know there were some issues. I am assuming this is has been fixed.
- o LDH: Thirty-day supply policy issues are fixed.

• Pharmacy Policy Memos

- M.J. Terrebonne: One was addressing the compound drug coverage to the MCOs.
- LDH: Still working on the 4/1 pharmacy policy memo. I believe there is one class where we are trying to get testing to approve.

Council Letter to Secretary Abraham

 M.J. Terrebonne: The letter was submitted to the Secretary, Undersecretary, and Drew. We have not received a response, yet.
