EX PARTE PETITION TO MAKE ADMINISTRATIVE ORDER(S) EXECUTORY PURSUANT TO LA. R.S. 40:6(G)

The petition of Dr. Jimmy Guidry, M.D., in his official capacity as State Health Officer, Louisiana Department of Health ("LDH"), Office of Public Health, through undersigned counsel, respectfully represents:

1.

Dr. Jimmy Guidry, State Health Officer for LDH, Office of Public Health, is granted jurisdiction and authority to enforce the State Sanitary Code (Louisiana Administrative Code Title 51) pursuant to La. R.S. 40:4 and R.S. 40:5, and authority to issue Administrative Orders to public water systems pursuant to La. R.S. 40:5.9.

2.

Made defendant herein is the **Village of Sikes** (hereinafter "Defendant"), a political subdivision of the State of Louisiana, headquartered at 212 2nd Street, Sikes, LA 71473.

3.

Defendant owns and operates a municipal water system that serves residents and businesses in Sikes, Louisiana. Said water system constitutes a "public water system" as defined in La. R.S. 40:5.8.

4.

A Notice of Imposition of Penalties ("NIP") issued pursuant to La. R.S. 40:4, 40:5, 40:5.9, 40:6, Sanitary Code Part I, §113, and Sanitary Code Part XII, §501 et seq., signed by Dr. Jimmy Guidry, State Health Officer, and Dr. M. Rony Francois then LDH\OPH Assistant Secretary, as authorized delegate for Alan Levine, then LDH Secretary, was delivered by certified mail, return receipt requested, to Defendant on or about July 30, 2009. A certified copy of the NIP, which bears the LDH-assigned number C-09-127-034-S1-DDBP-P-I is attached hereto as **Exhibit LDH-A**. The return receipt associated with the certified mailing of NIP No. C-09-127-034-S1-DDBP-P-I is attached hereto as **Exhibit LDH-B**.

As noted therein, the issuance of the NIP was preceded by the delivery to Defendant of one or more Post Order Inspection Reports ("POIR").

6.

LDH issued NIP No. C-09-127-034-S1-DDBP-P-I because Defendant failed to notify LDH in writing, as required by the POIR(s), that it had complied with Administrative Order No. C-06-127-034-S1-DDBP-AMO-I, previously issued to Defendant.

7.

Despite being properly served with NIP No. C-09-127-034-S1-DDBP-P-I, Defendant did not thereafter, within the twenty days allowed under Public Health Sanitary Code Part I, §113 or otherwise, submit to either LDH or the La. Division of Administrative Law any form of written request that might be construed as a request for an administrative appeal thereof.

8.

An <u>Administrative Order</u> issued pursuant to La. R.S. 40:4, 40:5, 40:5.9, 40:6, and Sanitary Code (LAC Title 51) Part I, §111, signed by Dr. Jimmy Guidry, State Health Officer, and John Thomas Lane, then LDH\OPH Assistant Secretary, as authorized delegate for Kathy H. Kliebert, then LDH Secretary, was delivered by certified mail, return receipt requested, to Defendant on or about November, 2014 (actual date of delivery not inserted on Return Receipt by recipient). A certified copy of said Administrative Order, which bears the LDH-assigned number C-14-127-034-DDBP-M-I, together with any attachments thereto, is attached to this petition as **Exhibit LDH-C**. The return receipt associated with the certified mailing of Administrative Order No. C-14-127-034-DDBP-M-I is attached hereto as **Exhibit LDH-D**.

9.

As more particularly described therein, Administrative Order No. C-14-127-034-DDBP-M-I was issued only after LDH personnel conducted various inspections and provided Defendant with all notice(s) required under Sanitary Code Part I.

10.

Despite being properly served with Administrative Order No. C-14-127-034-DDBP-M-I, Defendant did not thereafter, within the twenty days allowed under Sanitary Code Part I, §111 or otherwise, submit to either LDH or the La. Division of Administrative Law any form of written request that might be construed as a request for an administrative appeal of said Administrative

A Notice of Imposition of Penalties ("NIP") issued pursuant to La. R.S. 40:4, 40:5, 40:5.9, 40:6, Sanitary Code Part I, §113, and Sanitary Code Part XII, §501 *et seq.*, signed by Dr. Jimmy Guidry and Rebekah E. Gee, MD, MPH, was delivered by certified mail, return receipt requested, to Defendant on or about August 22, 2016. A certified copy of the NIP, which bears the LDH-assigned number C-14-127-034-DDBP-M-I-P-I is attached hereto as **Exhibit LDH-E**. The return receipt associated with the certified mailing of NIP No. C-14-127-034-DDBP-M-I-P-I is attached hereto as **Exhibit LDH-F**.

12.

As noted therein, the issuance of the NIP was preceded by the delivery to Defendant of one or more Post Order Inspection Reports ("POIR").

13.

LDH issued NIP No. C-14-127-034-DDBP-M-I-P-I because Defendant failed to notify LDH in writing, as required by the POIR(s), that it had complied with Administrative Order No. C-14-127-034-DDBP-M-I.

14.

Despite being properly served with the NIP No. C-14-127-034-DDBP-M-I-P-I, Defendant did not thereafter, within the twenty days allowed under Public Health Sanitary Code Part I, §113 or otherwise, submit to either LDH or the La. Division of Administrative Law any form of written request that might be construed as a request for an administrative appeal thereof.

15.

The Defendant has not complied with all of the actions required by Administrative Order No. C-14-127-034-DDBP-M-I, nor paid the penalty assessed by NIP No. C-09-127-034-S1-DDBP-P-I or NIP No. C-14-127-034-DDBP-M-I-P-I. LDH is thus entitled to an ex parte judgment making Administrative Order No. C-14-127-034-DDBP-M-I, NIP No. C-09-127-034-S1-DDBP-P-I, and NIP No. C-14-127-034-DDBP-M-I-P-I a judgment of the district court and making the judgment executory, pursuant to La. R.S. 40:6(G).

16.

Petitioner also suggests that the filing of this Petition and attached documents should be free from payment of any costs of court or other security bonds pursuant to La. R.S. 40:31, which

exempts the Department of Health, and its agents and subdivisions, from court costs in any suit.

WHEREFORE, petitioner Dr. Jimmy Guidry, State Health Officer, Louisiana Department of Health ("LDH"), Office of Public Health, prays that Administrative Order No. C-14-127-034-

DDBP-M-I, NIP No. C-09-127-034-S1-DDBP-P-I, and NIP No. C-14-127-034-DDBP-M-I-P-I be

made executory in this court, pursuant to La. R.S. 40:6(G), that all costs of these proceedings be

taxed against the Defendant, and for all other general and equitable relief warranted.
