#### Description

Lurbinectedin (Zepzelca<sup>™</sup>) is an alkylating drug.

#### FDA Approved Indication(s)

Zepzelca is indicated for the treatment of adult patients with metastatic small cell lung cancer (SCLC) with disease progression on or after platinum-based chemotherapy.

This indication is approved under accelerated approval based on overall response rate and duration of response. Continued approval for this indication may be contingent upon verification and description of clinical benefit in a confirmatory trial(s)).

#### Policy/Criteria

Provider must submit documentation (including such as office chart notes, lab results or other clinical information) supporting that member has met all approval criteria.

It is the policy of Louisiana Healthcare Connections® that Zepzelca is **medically necessary** when the following criteria are met:

### I. Initial Approval Criteria

### A. Small Cell Lung Cancer (must meet all):

- 1. Diagnosis of advanced or metastatic SCLC;
- 2. Prescribed by or in consultation with an oncologist;
- 3. Age  $\geq$  18 years;
- 4. Prescribed as single-agent therapy;
- Disease has progressed on or after platinum-containing regimen (e.g., cisplatin, carboplatin);
- 6. Request meets one of the following (a or b):\*
  - a. Dose does not exceed 3.2 mg/m² every 21 days;
  - b. Dose is supported by practice guidelines or peer-reviewed literature for the relevant off-label use (*prescriber must submit supporting evidence*).

\*Prescribed regimen must be FDA-approved or recommended by NCCN

**Approval duration:** 6 months

**B. Other diagnoses/indications** (must meet 1 or 2):

- If the requested use (e.g., diagnosis, age, dosing regimen) is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized) AND criterion 1 above does not apply, refer to the off-label use policy for the relevant line of business: LA.PMN.53 for Medicaid.

### **II. Continued Therapy**

# A. Small Cell Lung Cancer (must meet all):

- Currently receiving medication via Louisiana Healthcare Connections benefit, or documentation supports that member is currently receiving Zepzelca for a covered indication and has received this medication for at least 30 days;
- 2. Member is responding positively to therapy;
- 3. Prescribed as single-agent therapy;
- 4. If request is for a dose increase, request meets one of the following (a or b):\*
  - a. New dose does not exceed 3.2 mg/m<sup>2</sup> every 21 days;
  - b. New dose is supported by practice guidelines or peer-reviewed literature for the relevant off-label use (prescriber must submit supporting evidence).

\*Prescribed regimen must be FDA-approved or recommended by NCCN

**Approval duration:** 12 months

### **B. Other diagnoses/indications** (must meet 1 or 2):

- If this drug has recently (within the last 6 months) undergone a label change (e.g., newly approved indication, age expansion, new dosing regimen) that is not yet reflected in this policy, refer to LA.PMN.255
- If the requested use (e.g., diagnosis, age, dosing regimen) is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized) AND criterion 1 above does not apply, refer to the off-label use policy for the relevant line of business: LA.PMN.53 for Medicaid.

# III.Diagnoses/Indications for which coverage is NOT authorized:

A. Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off-label use policies – LA.PMN.53 for Medicaid, or evidence of coverage documents.
