Highlights and News

- The WAAs and FSO continue to use telehealth while also resuming some face-to-face contact with families while continuing with CDC safety precautions.
- The Families First Coronavirus Response Act (FFCRA) changes to CSoC disenrollment criteria remain in place and will continue at this time.
- Referrals to CSoC have been down during the summer months, however several efforts to increase referrals are in progress, including direct referral pilots between Magellan and OJJ, DCFS, PRTFs and a few hospitals.
- ► CMS approved 500 additional slots for CSoC.
- Outcomes overall remain positive.










Child and Adolescent Needs and Strengths (CANS) Outcomes: Clinical Functioning






Child and Adolescent Needs and Strengths (CANS) Outcomes: Domain Scores




Parent/Youth Support and Training Utilization




