

Louisiana Coordinated System of Care (CSoC) Director's Report to the Governance Board

5/25/2022



Highlights and News

- The WAAs and FSO have increased the level of face-to-face contact with families while continuing with CDC safety precautions. Agencies are utilizing telehealth when requested by families.
- The Families First Coronavirus Response Act (FFCRA) changes to CSoC disenrollment criteria remain in place, however Medicaid and OBH are assisting the agencies with disenrollment of identified members who meet full Medicaid benefit eligibility outside of CSoC and meet specific CSoC discharge criteria pre-COVID19.
- Magellan is continuing to take direct referrals to CSoC and this has yielded very positive results. Magellan reports that the majority of all referrals received are made by contacting them directly.
- The number of referrals continued to increase this quarter.



Highlights and News

- The OBH CSoC team, Magellan, the Wraparound Agencies and the FSO continue to bring awareness to CSoC through presentations to the MCOs, providers, LDOE, DCFS & OJJ; collaboration with OCDD; and targeted outreach to hospital staff.
- Magellan partnered with OCDD who hosted and presented a two-part training to wraparound agencies and the FSO on coordinating care for children with Autism.
- LDH (OBH CSoC team, OBH Child Clinical Systems Team and LDH Legal) will be facilitating a "Court Involved Youth" training for all nine wraparound agencies this month.
- Outcomes overall remain positive.



Age Groups












Child and Adolescent Needs and Strengths (CANS) Outcomes: Clinical Functioning






CANS Outcomes: Reduction in Prevalence of Actionable Needs (2021)
