# **Roll Call**

# **Director's Report**

Data for reporting period October 1, 2023 through December 31, 2023 were presented via PowerPoint slides, which were also emailed to members. Sareda McPhee, CSoC Director, discussed highlights of the report; shared recent news, successes, and community outreach events from wraparound agencies; and invited questions from board members. Sareda thanked National Child and Family Services (NCFS) for serving as a CSoC wraparound agency for 11 years, and thanked Eckerd Connects for now serving members in Region 1 and Ascent Health for now serving members in Region 2. During the discussion, Karen A. asked if the increase in referrals from DCFS is due to recent outreach by the new wraparound agencies in Regions 1 and 2. Sareda shared that they could indeed be related. There was also discussion regarding inpatient stays and the average length of stay typically being lower for CSoC youth than other Medicaid youth. Michael asked about the intent to discharge process for disengaged youth. Sareda shared details about the process.

Heather Barnes, Executive Director of Behavioral Services of Louisiana, shared FSO updates and a success story from Region 4.

Yolonda moved and Karen A. seconded a motion to approve the Director's Report.
