LA Medicaid Public Health Emergency CAA Unwind

• Charlene Julien, Eligibility Deputy Director presented

- April 2023 Medicaid will start reviewing eligibility; Two million members eligibility will be reviewed
- May 1, 2023 disenrollment letter sent to members and will be effective July 1, 2023
- Call center will offer extended hours during the beginning of this phase
- Based on data prior to the PHE, 350,000 possible terminations. LDH is not 100% certain.

Provider Enrollment

- Providers and MCOs reminded of IB 22-38 and provider enrollment portal help desk
- LDH is aware of claim denials and working with MCOs to identify the providers. The MCOs were asked to make outreach to get the provider enrolled and to possibly reprocess the denied claims.

Credentialing Affiliated Providers

- Act 143 House Bill 286
- Effective 8/1/2022
- Overview provided; Law applies to new provider and providers recredentialing with MCO. If a
 provider has privileges at a hospital the MCO will not require a full application. However,
 appropriate privilege documentation is required to be submitted to the MCO.

CPT codes that change during surgery

- LDH received provider complaint that this happens during hysterectomy procedures
- LDH requested all six MCOs to submit their policies pertaining to PA requirements by cob 2/24/2023

Independent Review Reminders

- Ways to submit an IR
- Independent review mailbox should be copied on all IR emails
- All six MCOs accept IRR submissions via email
- Preferred LDH IR submission is electronically and at this time certified mail is still an option

• NEW: Claim corrections and reprocessing are required to be completed **within 15 calendar days** of discovery.
