Medicaid Leadership Update

- Rachel Newman-new CFO
- Effective, August 14, 2023, Kimberly Sullivan is the interim Medicaid Executive Director
- The current director, Tara LeBlanc, will retire on September 30, 2023



Louisiana Medicaid

- Over two million residents (adults and children), receive health care coverage through Louisiana Medicaid.
- Over 90% of our Medicaid population is enrolled through one of our Managed Care Organizations (MCOs).





Medicaid Renewal

- Redeterminations for all of our members will be spread over 12 months.
- If the member's coverage cannot be extended through the ex parte process, a prepopulated renewal form with the latest information the agency has on file will be mailed to them.
- If Medicaid members do not respond, they can risk losing their coverage even if they are still eligible.

June Disenrollments and Updates

- Medicaid renewals restarted April 2023 with the unwind process
 - Total beneficiaries for whom a renewal was initiated 151,564
 - Number of beneficiaries who renewed 91,096
 - Number of beneficiaries determined ineligible 12,984
 - Number of beneficiaries closed for failure to respond 37,697
- We continue to monitor monthly



LDH Current Efforts

- LDH has engaged with partners for grassroots outreach including:
 - Neighborhood canvassing
 - Hosting and attending community events
 - Using phone banks
 - Coverage at sporting events and festivals
 - Outreach to faith-based leaders

LDH Key Messages to Members

- Update your contact information including your address, phone number, cell phone number and email address
- Read mail from Medicaid
- Respond to mail from Medicaid or you risk losing your coverage even if you are still eligible





MCO Efforts

- Our MCOs are working in collaboration with us and mirroring outreach efforts.
- They are supporting us by processing returned mail and reaching out to members in an attempt to connect and update their information.
- MCOs are getting updated contact information from members and sharing those updates with us.
- MCOs support with targeted outreach when they receive files from Louisiana Medicaid composed of a list of members who are scheduled to renew coverage.

- Four public universities awarded




