SUBJECT: Updates to Assistive Devices and Medical Supplies (ADMS) Procurement Service

Effective 1/1/24, the Louisiana Department of Health (LDH) – Office of Aging and Adult Services (OAAS) is pleased to announce that we have made some changes to one of the procedure codes under the Assistive Devices and Medical Supplies (ADMS) services. For the ADMS procurement service, we have added Support Coordination Agencies (SCAs) as a provider type and increased the units/rates for this service.
