# Community Life Engagement Development

**Community Life Engagement Development (CLED)** is a service that is used to locate and develop opportunities in the community that reflect the expressed interests of an individual or exploring new activities that lead to new interests.

# Community Life Engagement Development

## Goals for the Individual:

- Increase in their participation and involvement in their community
- Integration with people in their community
- Develop new areas of interests
- Develop connections to their community
- Establish routines they look forward to each day, week, month
- Develop a more meaningful day for the person!

# Community Life Engagement Development

## Facts:

- This service is available to those in the NOW, ROW or Supports Waiver
- Day Habilitation services must also be listed on the plan of care (POC) in order to receive CLED
- CLED may be provided in a 1:1, 1:2 or 1:3 ratio (but only the 1:1 code is listed on the POC)
- The service units are '**shared and flexed**' across 1:1, 1:2 or 1:3 ratio by the provider

# Community Life Engagement Development

## Facts:

- Transportation cost is included in the rate paid to the provider
- The same community contact may be billed for up to three people, but the same contact may NOT be billed for additional individuals with the same interest because the contact is already established
- CLED may be billed at the same time as another service since the individual is not required to be present for the delivery of this service

# Community Life Engagement Development

## Requirements:

- Provided by a licensed ADC provider with the Day Habilitation module
- EVV is used by provider when the contact is made
- CLED Contract Form is completed and filed in the individual's case record, a copy sent to the LGE and the SC
- At the quarterly/annual meetings, the provider should be prepared to discuss the contacts and connections that have been made for the individual and how the individual's community life engagement activities have increased
