1. RFP Sections II.A.3.7, page 13 and II.B.2.3, page 19

Question: The RFP requests that the Contractor assist the Department in developing the P&T Committee minutes following the meeting. This activity is not limited to record keeping during the meeting and assistance in writing the minutes 30 days or more after the meeting. Is it the State's expectation that the minutes will be compiled at the same level of detail as the currently available minutes?

Response: Yes, the State's expectation is that the minutes will be compiled at the same level of detail as currently.

2. RFP Section II.A.3.4.5, page 17

Question: Federal Rebate services are not part of the current contract; these services will not be provided until the MMIS contract goes live in 2014. Can the State provide clarification as to what is expected in relation to Federal Rebate services for the SR/PDL program? Also, please provide a definition of "CCN."

Response: In RFP Section II.A.3.4.5 in regards to Federal rebate, the section indicates the supplemental rebate submissions should be coordinated with the submission of the Federal rebates. Contractor will provide the necessary documentation to the Department to support the supplemental rebate billings along with amounts to submit to the manufacturers at the NDC level in a format as specified by the Department and the rebate agreements. The phrase 'unless covered by a CCN' was erroneously included in this section. The sentence should read: "Coordinating the supplemental rebate submission with submission of traditional Federal rebates."

3. RFP Section II.B.2.3.4, page 20

Question: The RFP requires the Contractor to track the effective dates of all Supplemental Rebate agreements and provide the Department with a Monthly Supplemental Rebate Agreement report. This information is currently provided by the Contractor in the Monthly Contract Status report required in RFP Section II.B.2.3.1. Is the Monthly Contract Status Report different than the Monthly Supplemental Rebate Report?

Response: The Monthly Supplemental Rebate Program and the Monthly Contract Status Report are the same 4. Are specialty drugs allowed to participate in the Supplemental Rebate process?

Response: This question is not relevant to the RFP.

5. Will the state accept a Supplemental Rebate for an FDA approved drug that is covered under the medical benefit?

Response: This question is not relevant to the RFP.

6. If so, can the Supplemental Rebate offer directly cover home infusion services? In other words, through this process, could the cost of home infusion services be covered by the company (Dyax) as the Supplemental Rebate? The patient could still seek treatment in an Emergency Room or at the provider's office.

7. What are the current treatment options for Louisiana Medicaid patients with Hereditary Angioedema (HAE)?
