Notes:

- Enrollment is calculated by counting anyone enrolled at any point in the month. Prior to November 2018 enrollment only counted someone who was enrolled at the date the report was generated.
- All counts are unduplicated in each individual type of assistance category per month. One person may be counted multiple times if they changed Type of Assistance in the month; therefore the number of enrollees by type of assistance will not equal the Total Unduplicated count for the month.
- Data for each month is as of the 1st of the subsequent month. For example, the May 2020 enrollment is as of 06/01/2020.
- This report is a rolling 12 month period.
