MEMORANDUM

In accordance with the Administrative Procedure Act (La. R.S. 40: 950 et seq.) as amended, the Louisiana Department of Health, Office of Public Health, is submitting the following emergency rule that amends LAC 50:1.2111, Dental Benefits Prepaid Ambulatory Health Plan Network Provider Reimbursement.

This action is being taken as authorized by R.S. 36:254 and pursuant to Title XIX of the Social Security Act. The changes amend the provisions governing coverage of Dental Benefit Plan Manager (DBPM) to provide reimbursement to dental providers. It provides for increases in the reimbursement rates for dental exams for children under three (3) years of age and restorative dental services provided to Medicaid recipients. This action is being taken to promote the health and welfare of Medicaid recipients by ensuring continued access to dental services.

DECLARATION OF EMERGENCY

Department of Health Bureau of Health Services Financing

Dental Benefits Prepaid Ambulatory Health Plan Network Provider Reimbursement (LAC 50:1.2111)

The Department of Health, Bureau of Health Services

Financing amends LAC 50:I.2111 in the Medical Assistance Program

as authorized by R.S. 36:254 and pursuant to Title XIX of the

Social Security Act. This Emergency Rule is promulgated in

accordance with the provisions of the Administrative Procedure

Act, R.S. 49:953(B)(1) et seq., and shall be in effect for the

maximum period allowed under the Act or until adoption of the

final Rule, whichever occurs first.

Act 10 of the 2019 Regular Session of the Louisiana

Legislature directed the Department of Health, Bureau of Health

Services Financing to increase reimbursement rates for dental

exams for children under three years of age and restorative

dental services provided to Medicaid recipients. In compliance

with Act 10, the department amends the provisions governing the

dental benefits prepaid ambulatory health plan in order to

increase reimbursement for dental exams for children under three

years of age and restorative dental services.

This action is being taken to promote the health and welfare of Medicaid recipients by ensuring continued access to

dental services. It is estimated that implementation of this Emergency Rule will increase programmatic costs in the Medicaid Program by \$7,780,273 for state fiscal year 2019-2020.

Effective March 23, 2020 the Department of Health, Bureau of Health Services Financing amends the provisions governing the dental benefits prepaid ambulatory health plan in order to increase reimbursement for dental exams for children under three years of age and restorative dental services.

- H. Network Provider Reimbursement
- 1. The DBPM shall provide reimbursement for defined core dental benefits and services provided by an in-network provider pursuant to the terms of its contract with. The DBPM rate of reimbursement shall be no less than the published Medicaid fee for service rate in effect on July 1, 2013, unless the department has granted an exception for a provider initiated alternative payment arrangement.
