# 17-0026 Proton Beam Radiation Therapy Termination Effective date: February 20, 2018 (or upon promulgation of the Rule)

The purpose of this SPA is to amend the provisions governing laboratory and radiology services to terminate coverage and reimbursement for proton beam radiation therapy (PBRT) rendered to recipients 21 years of age and older.

#### <u>17-0033 Behavioral Health Services - Substance Use Disorders Services</u> Effective date: February 20, 2018

The purpose of this SPA is to amend the provisions governing substance use disorders (SUD) services rendered to children and adults in order to: 1) reflect the coordinated system of care contractor moving from a non-risk contract to a full-risk capitated contract; 2) remove the requirements for the Office of Behavioral Health certification of providers and for prior approval of SUD services; 3) clarify the exclusion criteria for institutes for mental disease; and 4) clarify the requirements for residential addiction treatment facilities.

## 17-0034 Children's Behavioral Health Services Effective date: February 20, 2018

The purpose of this SPA is to amend the provisions governing children's behavioral health services in order to: 1) reflect the coordinated system of care contractor moving from a non-risk contract to a full-risk capitated contract; 2) remove the requirements for the Office Behavioral Health certification of providers and for prior approval of services; and 3) clarify the exclusion criteria for services rendered by institutes for mental disease.

# 17-0035 Therapeutic Group Homes Effective date: February 20, 2018

The purpose of this SPA is to amend the provisions governing therapeutic group homes (TGH) in order to: 1) reflect the coordinated system of care (CSoC) contractor moving from a non-risk contract to a full-risk capitated contract; 2) remove the requirement for the Office of Behavioral Health certification of providers; and 3) reflect that TGHs are carved out of management by the CSoC contractor to align with current practice and contract requirements.
