Federally Qualified Health Centers Alternative Payment Methodology Effective date: July 1, 2021

The purpose of this SPA is to amend the provisions governing Federally Qualified Health Centers (FQHCs) in order to establish an alternative payment methodology that requires managed care organizations to pay each FQHC an encounter rate that is at least equal to the prospective payment system base rate specific to each FQHC.

Rural Health Clinics Alternative Payment Methodology Effective date: July 1, 2021

The purpose of this SPA is to amend the provisions governing Rural Health Clinics (RHCs) in order to establish an alternative payment methodology that requires managed care organizations to pay each RHC an encounter rate that is at least equal to the prospective payment system base rate specific to each RHC.

Behavioral Health Services Effective date: January 1, 2022

The purpose of this SPA is to amend the provisions governing Children's Behavioral Health Services in order to revise provider and staff qualifications relative to Psychosocial Rehabilitation services.
