State Plan Amendments for Submittal to CMS

Request for Tribal Comments May 28, 2021

Intermediate Care Facilities for Individuals with Intellectual Disabilities (ICF-IID) - Reimbursement Methodology Effective date: August 20, 2021

The purpose of this SPA is to amend the provisions governing reimbursement methodology for intermediate care facilities for persons with intellectual disabilities in order to place an effective date on direct care floor recoupment.

Targeted Case Management Effective date: August 20, 2021

The purpose of this SPA is to amend the provisions governing the targeted case management program in order to repeal the agency caseload limitations regarding the maximum number of recipients that any one agency may serve in a region.

Medicaid Eligibility – Twelve Months Continuous Eligibility Effective date: April 1, 2021

The purpose of this SPA is to amend the provisions governing eligibility for the Medical Assistance Program to update the list of beneficiaries under the age 19 for whom twelve months of continuous eligibility is not available.

Recovery Audit Contractor Effective August 6, 2021

The purpose of the SPA is to request an extension of the exemption from participation in the Recovery Audit Contractor Program.
