### **Pharmacy Benefits Program - Over the Counter Drugs Effective date: December 20, 2023**

The purpose of this SPA is to amend the provisions governing the Pharmacy Benefit Management program in order to remove references to specific over the counter (OTC) drugs that are covered under the State Plan.

## Professional Services Program Effective date: December 20, 2023

The purpose of this SPA is to amend the provisions governing the Professional Services program in order to align with current practices.

# **Targeted Case Management Program Effective date: December 20, 2023**

The purpose of this SPA is to amend the provisions governing targeted case management (TCM) in order to clarify language and ensure the requirements for TCM services are accurately reflected throughout the State Plan.
