<div>  <div>           Operations &amp; Maintenance         </div> </div>	<div>           Points deducted for operation and maintenance deficiencies noted during water system inspections, which may affect the water quality being distributed to consumers.           <div>Max of 15 points</div> </div>	<div>-0</div>
<div>  <div>           Infrastructure         </div> </div>	<div>           Points deducted for infrastructure deficiencies noted during water system inspections, which may lead to unsafe drinking water and/or water service disruption.           <div>Max of 20 points</div> </div>	<div>-5</div>
<div>  <div>           Customer Satisfaction         </div> </div>	<div>           Points deducted for customer complaints received by the water system and/or the Louisiana Department of Health, which are confirmed to be a water quality or quantity issue in the water system.           <div>Max of 10 points</div> </div>	<div>-0</div>
<div>  <div>           Secondary Contaminants         </div> </div>	<div>           Points deducted for levels of iron and/or manganese greater than the secondary maximum contaminant levels. These levels do not pose a health risk but may cause undesirable water quality issues.           <div>Max of 5 points</div> </div>	<div>-0</div>
<div>  </div>	<div>           Points granted for having an asset management plan; a storage assessment and maintenance program; well assessment &amp; maintenance program; participation in management training; or participation in a capacity development program.           <div>Max of 10 points</div> </div>	<div>+10</div>
