#### Addendum to the RFP

## Page 1, Glossary:

- Add HIPAA: Health Insurance Portability and Accountability Act of 1996
- HiTECH <u>Act</u>: Health Information Technology for Economic and Clinical Health Act of 2009

### Page 12, Client Confidentiality and Data Security:

Replace the first sentence of the first paragraph with the following:

The Contractor must be compliant with all <u>applicable privacy and security</u> requirements imposed by LDH or the Division of Administration, Office of Technology Services, as well as the requirements of the HIPAA Guidelines and the federal HiTECH Acts <u>and their associated regulations.</u>

#### Page 20, D. Rejection and Cancellation, #4

Remove the following from the last sentence:

Title 39, Chapter 16 (professional, personal, consulting, and social services procurement);

#### Page 21, E. Contract Award and Execution, #4

Replace with the following:

4. If the contract negotiation period exceeds thirty (30) <u>calendar days</u> or if the selected Proposer fails to sign the final contract within fifteen (15) <u>business days</u> of delivery, the State may elect to cancel the award and award the contract to the next-highest-ranked Proposer.

## Replace with the following:

2. Proposer shall submit one (1) original hard copy (The Certification Statement must have original signature signed in ink), five (5) duplicate hard copies, and one (1) electronic copy (CD or USB flash drive) of its complete proposal. Proposer shall also submit one (1) electronic copy (CD or USB flash drive) of its redacted proposal, if applicable. All electronic copies must be searchable. No facsimile or emailed proposals will be accepted. The cost proposal and financial statements shall be submitted separately from the technical proposal; however, for mailing purposes, all packages may be shipped in one container.

## Page 24, Q. Proposal Content, #2. Table of Contents

Replace with the following:

The contents of the proposal should be organized in the order set forth in section IV.P above.

## Page 28-29, Data System

Replace the last sentence of the fourth paragraph with the following:

Include description of how the interface provides secure/encrypted data transmission in compliance with all applicable security requirements imposed by LDH or the Division of Administration, Office of Technology Services, as well as the requirements of the HIPAA and HiTECH Acts and their associated regulations.

#### Page 30, Client Confidentiality and Data Security

- Replace the second sentence of the first paragraph with the following:

The Contractor must be compliant with all applicable privacy and security requirements imposed by LDH or the Division of Administration, Office of Technology Services, as well as the requirements of the HIPAA and HiTECH Acts and their associated regulations.

- Replace the last paragraph with the following:

Provide a detailed description of how secure data will be transmitted between the different parties involved in pharmacy service coordination (CMS, SHP, insurance plans, Medicare Part D PDPs, and pharmacies), in compliance with security requirements imposed by LDH or the Division of Administration, Office of Technology Services and the requirements of the HIPAA and HiTECH Acts and their associated regulations, as well as satisfying industry standards and practices.
