§1059.1. Legislative findings; Louisiana Doula Registry Board; purpose; composition; duties of the board; rulemaking authority

B.(1)(a) The legislature hereby creates within the Louisiana Department of Health the Louisiana Doula Registry Board, hereafter referred to in this Section as the "doula registry board", for the purpose of reviewing and approving doula registration to allow for health insurance reimbursement of doula services. (b) The doula registry board shall create the criteria for the registration application, review submitted doula registration applications, and grant registration status to doulas seeking health insurance reimbursement to promote safe and equitable care for every mother and every birth in this state.

C. The doula registry board shall perform all of the following tasks:

- (1) Review applications for doulas to register to receive health insurance reimbursement in Louisiana.
- (2) Approve applications to designate registered doula status.
- (3) Notify applicants of approval or denial of doula registration status.
- (4) Maintain a statewide registry of doulas approved for health insurance reimbursement in Louisiana.
